B. OPEB Report

T. Hoar went over a summary of the 2019 OPEB Actuarial. The summary showed that our OPEB liability continues to decrease and our market value of assets and % funded continues to increase. For 2020, our plan is 45.31% funded.

9. Manager's Report

A. MDOT Increase & Hiring - With the increase in MDOT funding and the additional work it brings to our crew, I think it would make sense to consider hiring another full-time employee. The increase is a guaranteed increase to our contract budget and not just a one-year increase. The winter budget decreased by \$30,795 (based on 5-year average) and the summer budget increased by \$214,732. Per Tanya's summary the true cost for a new employee (based on today's rates) is approximately \$68,975. That leaves \$114,962 to complete the additional work requested by MDOT. MDOT has suggested that some of the additional funding be utilized to increase workforce if needed.
